On the basis of the Art. 14 from the Statute of the Citizens Association-Association for GS1 standards – GS 1 Macedonia, the Managing Board of the GS1 Macedonia on the XIIIth assembly held on the December 26th 2014 has issued the

DECISION

for establishment of the subscription fee membership fee and membership dues amount for use of the GS1 number in the year 2015

Art. 1

The amount for subscription fee, membership fee and the membership dues for use of the GS1 number in the GS1 Macedonia for year 2015 are as follows:

Art. 2

The subscription fee is payable once at the occasion of subscription, while the membership fee and the membership dues for the membership in the GS1 Macedonia and for the use of the GS1 Macedonia's number are payable every year.

The subscription fee and the membership fee are (VAT) DDV 18% exempt.

The membership dues for use of the GS1 number are (VAT) DDV 18% inclusive.

All the above mentioned amounts are payable on the GS1 Macedonia's account no. 200002024739774 at the Stopanska Banka AD Skopje.

Art. 3

On member's request for enlargement of the bar-coding capacities, whatever volume should it be (from 10 to 100, from 100 to 1.000, from 1.000 to 10.000, from 10.000 to 100.000 bar-coded articles) a new Unique Registration GS1 number shall be allocated. The member is bound to pay in full the

obligations related to annual membership fee and membership dues for use of the GS1 number and for the two allocated GS1 numbers.

Art. 4

On member's request for enlargement of the bar-coding capacity of the same volume, the new Unique Registration number shall be allocated. The member is bound to pay in full the obligations related to the annual membership fee and membership dues for use of the GS1 number and for the two allocated GS1 numbers.

Art. 5

In all cases when, on Company's request, the same Company is repeatedly enlisted in the National and in the International Register, a new Unique Registration GS1 number with a new Company's prefix, shall be allocated. Or, in case of undertaking the Unique Registration number for bar-coding from another company, the additional charges for preparatory works on complete documentation are amounting to 8.000,00 MKD plus (VAT) DDV 18 %.

Art. 6

On member's request for additional services for working out complementary exemplars of the original Accreditation Plaque, the charges amount to 200,00 MKD each, while working out the Accreditation Plaque with frame the same are amounting to 750,00 MKD. Services are charged with (VAT) DDV 18 %.

Art. 7

On member's request for additional service for issuing again the original Decision for allocation of the Unique Registration GS1 number, the charge is 620,00 MKD plus (VAT) DDV 18%.

Art. 8

If the member, once excluded from the membership, according to the Art. 26 and the Art.28 of the GS1 Macedonia's Statute, is willing to restore its enrolment and make a renewal of the previous GS1 number, shall be indebted to a double tax payment for the subscription fee (30.000,00 MKD) and shall be obliged to settle up all the outstanding debts related to unpaid membership fees and membership dues for the use of the GS1 number.

Art. 9

If the member, after its exclusion and cancellation from the Register of members, continue to use the Unique Registration GS1 number, in unauthorized and unaccredited way, i.e. illegally, the same will be subject to judicial pursuit and legal process penalty, while GS1 Macedonia will accordingly inform the competent inspection's authorities, the wholesalers, distribution networks, large supermarkets, by announcing the occurrence on the GS1 Macedonia web-site and in the International Register GEPIR.

Art.10

This Decision is entering into force on the date of January the 1st 2015 and will be announced on the GS1 Macedonia's web-site.
